ARD REMOVAL HEARINGS

You are here this afternoon because you violated your ARD Probation in some way (for example: failure to pay costs in full, failure to complete DUI conditions, community service, new arrest, positive drug screens, failure to report onto monitor connect.)

I will meet with all of you individually. One of two things will happen. You may be granted an extension on you ARD probation to give you more time to complete your conditions or you will be removed from the program. If you are removed, you will receive a trial date in the mail.

If you are granted your short extension I will give you a **NEW END DATE TO YOUR PROBATION**. **DO NOT RETURN** on that date. It is NOT a new court date. It is the new date that you must have everything completed by. If everything is not completed by that date you will be automatically removed from ARD and you will receive a trial date in the mail. You are only able to receive ONE extension so make sure you complete everything within that period of time. Once I give you your extension you are free to go.

If you have a new arrest you will not be permitted to remain in the ARD Program. You will receive a trial date in the mail.

You are NOT required to log onto MONITOR CONNECT after today's date.
