**ADDENDUM TO GUILTY PLEA COLLOQUY
FOR SEXUAL OFFENDERS**

You are present before this court because you, or your lawyer, have indicated a desire to enter a plea of guilty to some of all, of the criminal offenses listed in the Sexual Offender Registration and Notification Act, 42 Pa. C.S.A. Section 9799.10 et seq. (otherwise known as SORNA).

Please fully answer all of the questions on these papers. If you do not understand a question, indicate you do not understand by putting a question mark (“?”) in front of the number of the question you do not understand. The questions will be explained to you.

Most of the questions are planned to be answered either “YES” or “NO”.

When you have completed the questions, be sure to ask your lawyer, the attorney for the Commonwealth (Assistant District Attorney), or the Judge to explain any question you did not fully understand. The question will be explained and you must fully understand it and answer all of the questions before you sign at the bottom of the last page.
